# **Applications:**

Bilge, Grey & Black Water Treatment is an enzyme-based product that converts contaminants in bilge, grey and black water tanks and prevents odours.

The enzymes convert faecal matter and other contaminants in the tank, enabling the odour-free contents to be discharged safely. Can also be used during the winter to prevent odours from forming in boats. Does not affect hoses and rubber. 100% biodegradable.

#### Instructions for use:

- 1. For black water, add 1 to 2 litres to a clean tank per 1000 litres volume. For grey water, add max. 1 litre to a clean tank. For bilge cleaning, 1 litre, as required.
- If the tank is already full of contaminated water, a shock treatment may be required.
- Increase the maximum dosage by 100% and conversion will have completed after 24 hours (depending on conditions).

#### **Product usage:**

For black water, add 1 to 2 litres to a clean tank per 1000 litres volume. For grey water, add max. 1 litre to a clean tank. For bilge cleaning, 1 litre, as required.

# **Considerations during application:**

Always place a reference test on the to be treated surfaces in order to determine both adhesion and the technical and aesthetic result.
