Applications:

Surface Cleaner Wipes are wear-resistant wipes that are ideally suited as pre-treatment for a surface to be treated with Marine Coat or Gelcoat Premium Protector. Surface Cleaner Wipes degrease the surface and remove possible cleaning agent residues that may have a strong adverse effect on the preservation system to be applied.

Instructions for use:

- Clean the surface to be treated using Hull Cleaner Hard, Hull & Deck Cleaner Pro, Deep Clean or a combination thereof.
- Wipe the dry surface to be treated with a Surface Cleaner Wipe and let the product evaporate and dry completely (time depends on the temperature and relative humidity).
- It can then be determined via a top-drop test whether the surface is ready for preservation. If the test is negative, the surface should be cleaned again.

Product usage:

Depending on the technical maintenance condition and porosity of the substrate, the theoretical yield is in average 40-50 m2 p/ bucket (100 wipes).

The above usage is indicative and should be determined by first applying to a small test area.

Considerations during application:

Always place a reference test on the to be treated surfaces in order to determine both adhesion and the technical and aesthetic result.
