

Teak Protector Clear

Technical Data Sheet

Applications:

Teak Protector Clear is a transparent and high-quality protective agent for teak. It is based on the most innovative technologies. Offers long-term protection against the re-adhesion of dirt. It prevents soiling, drastically reducing the growth of algae. It also impregnates the wood, which makes it more durable and prevents deterioration. The top layer is also water and grease-repellent. The surface does not become shiny, and the product does not alter the colour. Ideal for maintaining new and greyed teak. Does not affect sealant and does not make the teak deck slippery.

Instructions for use:

1. Protect surfaces that cannot be treated.
2. Ensure sufficient ventilation.
3. Always shake the bottle well before use.
4. The surface to be treated must be completely clean and dry.
5. Apply the Teak Protector Clear with a brush or a cloth. Allow the product to soak in for a few minutes.
6. Thoroughly rub it out using a clean and dry cloth to remove excess product.
7. Repeat the treatment where necessary.

Product usage:

This depends entirely on the porosity and humidity level of the surface to be treated and the selected application method.

Depending on the surface porosity, coverage can vary between approximately 5 m² per litre for porous surfaces, to up to 15 m² per litre for slightly porous surfaces.

The above usage is indicative and should be determined by first applying to a small test area.

Considerations during application:

Always place a reference test on the to be treated surfaces in order to determine both adhesion and the technical and aesthetic result.
